AND I HEREBY covenant that, subject to any co-ownership rights of BASF Catalysts LLC or its predecessor-in-interest in Patent No. 6,799,137, I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

AND I HEREBY further covenant and agree that I will communicate to said BASF Catalysts LLC, its successors, legal representatives and assigns, upon its request any facts known to me respecting the Patents, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and use my best efforts to have the inventors of the Patents testify in any legal proceeding, and generally do everything possible to aid the said BASF Catalysts LLC, its successors, legal representatives and assigns, to obtain and enforce proper protection of Patents in all countries.
