**TERMINATION AND RELEASE OF
SECURITY INTEREST IN PATENTS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS (this "Termination"), is dated as of August 26, 2015, and made by Credit Suisse AG, in its capacity as collateral agent pursuant to the Security Agreement referred to below (in such capacity, the "Collateral Agent") to Bio-Lab, Inc., a Delaware corporation, whose principal place of business is 1725 North Brown Road, Lawrenceville, Georgia 30043 (the "Grantor").

WHEREAS, certain security interests (the "Interests") were granted by the Grantor to Collateral Agent in certain collateral, including the Patents (as hereinafter defined);

WHEREAS, the Interests were recorded in the Patent Assignment Division of the United States Patent and Trademark Office on April 7, 2015, at Reel 035386 and Frame 0401; and

WHEREAS, the Collateral Agent now desires to terminate and release the Interests.

NOW, THEREFORE, for good and valuable consideration, Collateral Agent hereby states as follows:

1. Definitions. The term "Patents", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the patents listed on Schedule A hereto. Capitalized terms used herein without definition are used as defined in the First Lien Security Agreement ("Security Agreement"), dated as of May 23, 2013, made by, *inter alios*, the Grantor by operation of a Supplement dated as of December 31, 2013 to the Security Agreement in favor of Collateral Agent and was further supplemented by the Grantor by a Supplement to the Security Agreement dated as of March 30, 2015.

2. Release of Security Interest. Collateral Agent hereby terminates the Interests and terminates, releases and discharges its collateral pledge, grant, assignment, lien and security interest in the Patents, without recourse, representation or warranty.
