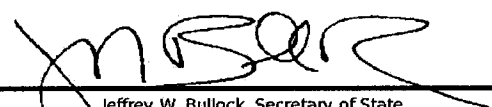

This Certificate of Conversion to Limited Liability Company, dated as of August 6, 2015, has been duly executed and is being filed by Informatica Corporation, a Delaware corporation (the "Company"), to convert the Company to Informatica LLC, a Delaware limited liability company (the "LLC"), under the Delaware Limited Liability Company Act (6 Del. C. § 18-101, et seq.) (the "Act") and the General Corporation Law of the State of Delaware (8 Del. C. § 101, et seq.) (the "DGCL").

1. The Company's name when it was originally incorporated was Informatica Corporation-Delaware and its name immediately prior to the filing of this Certificate of Conversion to Limited Liability Company was Informatica Corporation.

2. The Company filed its original certificate of incorporation with the Secretary of State of the State of Delaware and was first incorporated on March 4, 1999, in the State of Delaware.

3. The name of the LLC into which the Company shall be converted as set forth in its certificate of formation is Informatica LLC.

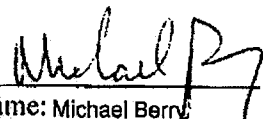
