**ASSIGNMENT OF PROVISIONAL APPLICATION**

**AND I HEREBY** covenant that I have full right to convey my entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

**AND I HEREBY** further covenant and agree that I will communicate to ASSIGNEE any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said improvements in all countries, provided that all my reasonable expenses and proper compensation for the time and costs, incurred after the date of execution of this assignment, associated with such testimony, review of papers, action regarding the applications and other matters regarding the said improvements are compensated, including reasonable legal fees, if any, in full by ASSIGNEE promptly upon receipt of papers evidencing such expenses and compensation.
