RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENTS (this “**Release**”), dated as of September 1, 2015, is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, a Swiss Bank with offices located at 11 Madison Avenue, New York, New York 10010, in its capacity as Collateral Agent (the “**Assignor**”), in favor of SNL FINANCIAL LC, a Virginia limited liability company with offices located at One SNL Plaza, Charlottesville, Virginia 22902 (the “**Assignee**”).

W I T N E S S E T H:

WHEREAS, the Assignee and the Assignor are parties to (i) that certain Guarantee and Collateral Agreement, dated as of October 23, 2012 (the “**Guarantee and Collateral Agreement**”) and (ii) that certain Patent Security Agreement, dated as of October 23, 2012 (the “**Patent Security Agreement**”);

WHEREAS, pursuant to the Patent Security Agreement, the Assignee pledged and granted to the Assignor, for the ratable benefit of the Secured Parties, a security interest in all right, title or interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by Assignee or in which Assignee had or at any time thereafter acquired any right, title or interest: (a) all patents issued by the United States or the equivalent thereof in any other country, and all applications for patents of the United States or the equivalent thereof in any other country, including issued patents and pending applications in the United States Patent and Trademark Office (or any successor or any similar offices in any other country), including those listed on Schedule I hereto; (b) all reissues, continuations, divisions, continuations-in-part, renewals or extensions thereof, and the inventions disclosed or claimed therein, including the right to make, use and/or sell the inventions disclosed or claimed therein (together with (a), the “**Patents**”); and (c) all Proceeds and products of any and all of the foregoing, all Supporting Obligations and all collateral security and guarantees given by any Person with respect to any of the foregoing (collectively, the “**Patent Collateral**”).

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on January 14, 2013 at Reel/Frame No. 29626/168; and

WHEREAS, the Assignee desires that the Assignor terminate and release its lien on and security interest in and to all right, title and interest in, to and under all of the Patent Collateral.

NOW THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor and the Assignee agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein but not defined herein shall have the meanings ascribed to such terms in the Patent Security Agreement.

SECTION 2. Termination and Release. The Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse of any kind, its lien on and security interest in and to all right, title and interest in, to and under the Patent Collateral, including the Patents listed on Schedule I attached hereto, and reassigns and transfers to the Assignee all right, title and interest that the Assignor may have in the Patent Collateral.

SECTION 3. Recordation. The Assignor hereby authorizes the Assignee, or the Assignee's authorized representative, to record this Release with the United States Patent and Trademark Office.


SECTION 4. Further Assurances. The Assignor hereby agrees to duly execute and deliver to the Assignee any further documents and to do such other acts that the Assignee (or its agents or designees) reasonably requests, at the Assignee's sole cost and expense, in order to confirm this Release and the Assignee's right, title and interest in the Patent Collateral.


SECTION 5. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
