ASSIGNMENT

Whereas we, Ziwei Ouyang of Vejlesøparken 1, 117, 2840 Holte, Denmark and Michael A. E. Andersen of Gurrehavevej 55, DK-3200 Helsingør, Denmark, have invented certain new and useful improvements in:

INTEGRATED MAGNETICS TRANSFORMER ASSEMBLY

And we hereby authorize and request the Director of the United States Patent and Trademark Office to issue said United States Letters Patent to said Assignee, as assignee of the whole right, title and interest thereto;

And we further agree to execute all necessary and lawful future documents, including assignments in favor of Assignee, or its designees as Assignee or its Assignees may from time-to-time present to us in order to perfect title in said Invention, modifications, and improvements in said Invention, applications and Letters Patent of the United States and countries foreign thereto;

And we further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing divisions, continuations and continuations-in-part of said application for patent, and/or, for obtaining any reissue or reissues of any Letters Patent that may be granted for my aforesaid Invention, as the Assignee thereof shall hereafter require and prepare at its own expense.

And we further authorize and direct my attorneys to insert below* the serial number and filing date of said application now identified as Docket No.: 42644-6104 as soon as the same shall have been made known to them by the United States Patent Office.
