ASSIGNMENT

This Assignment is made and entered into by and between Alessandra Carrer, residing at Road Roiata N. 38/A 33080 San Quirino-Pordenone (PN) (IT) (hereinafter "FIRST ASSIGNOR"), and Michela Muresco, residing at Road Augurello N. 11/F 31100 Treviso (TV) (IT), (hereinafter "SECOND ASSIGNOR"); and Giacomo Conte, residing at 8625 West Broad Street, Galloway, OH 43119 (US), (hereinafter "ASSIGNEE").

Whereas, FIRST ASSIGNOR and SECOND ASSIGNOR have invented certain inventions described in Italian Patent Application No. TV20130209, filed December 16, 2013, titled STRUTTURA DI CAPO DI ABBIGLIAMENTO PER IL SOLLEVAMENTO DEI GLUTEI E PER ASSOTTIGLIARE I FLANCHI; and United States Patent Application No. 14/823,668, filed August 11, 2015, titled GARMENT STRUCTURE TO LIFT GLUTEI AND THIN HIPS (Attorney Docket No. 32612/04010);

Whereas, by this Assignment, the right, title and interest in said applications and inventions will be held and distributed as follows: 50% to the ASSIGNEE, 25% to FIRST ASSIGNOR, and 25% to SECOND ASSIGNOR, the latter two together sharing 50% of the right, title and interest on said applications and inventions; and

Now, therefore, for good and valuable consideration, receipt of which is hereby acknowledged:

1. FIRST ASSIGNOR and SECOND ASSIGNOR hereby sell, assign, and transfer to ASSIGNEE, its successors and assigns, fifty percent (50%) of their collective right, title and interest, so far as concerns the United States and the Territories and Possessions thereof and all foreign countries, in and to the inventions set forth in the application for Italian Letters Patent and the application for United States Letters Patent currently or subsequently executed by FIRST ASSIGNOR and SECOND ASSIGNOR, said application for United States Letters Patent, any and all other applications for Letters Patent on said inventions in the United States and in countries foreign to the United States, including all divisional, renewal, extension, reexamination, substitute, continuation, continuation-in-part, reissue, and Convention applications based in whole or in part upon said inventions or upon said applications, and any and all Letters Patent and reissues and extension of Letters Patent granted for said inventions or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said applications and said Letters Patent.

2. ASSIGNEE is hereby authorized to file patent applications in any or all countries on any or all said inventions in the name of FIRST ASSIGNOR and SECOND ASSIGNOR 2 or in the name of

ASSIGNEE or otherwise as ASSIGNEE may deem advisable, under the International Convention or otherwise.

3. The Commissioner of Patents of the United States of America and the empowered officials of all other governments are hereby authorized to issue or transfer all said Letters Patent to ASSIGNEE in accordance herewith.

4. This Assignment is being made under covenant, not only that full power to make the same is had by FIRST ASSIGNOR and SECOND ASSIGNOR, but also that, at the time of execution of this Assignment, such assigned right is not encumbered by any grant, license, governmental restriction, or other right heretofore given.



FIRST ASSIGNOR and SECOND ASSIGNOR agree that they will do all acts reasonably serving to assure that said inventions, patent applications and Letters Patent shall be held and enjoyed by ASSIGNEE as fully and entirely as the same could have been held and enjoyed by FIRST ASSIGNOR and SECOND ASSIGNOR if this Assignment had not been made, and particularly to execute and deliver to ASSIGNEE all lawful documents including petitions, specifications, oaths, assignments, invention disclaimers, lawful affidavits, and declarations in form and in substance which may be requested by ASSIGNEE, to furnish ASSIGNEE with all facts relating to said inventions or the history thereof and any and all documents, photographs, models, samples or other physical exhibits which may be useful for establishing the facts of conception, disclosure and reduction to practice of said inventions, and to testify in any proceedings relating to said inventions, patent applications and Letters Patent.

6. FIRST ASSIGNOR and SECOND ASSIGNOR agree that this Assignment shall be construed in accordance with the laws and courts of Ohio. FIRST ASSIGNOR and SECOND ASSIGNOR hereby also agree to submit to the jurisdiction of any Ohio court.

7. FIRST ASSIGNOR and SECOND ASSIGNOR hereby request that ASSIGNEE or its counsel enter or correct the date(s) of execution of the afore-referenced Patent Application(s), and enter or correct the Application Serial Numbers if available, prior to recording this assignment, to have the same effect as if entered prior to execution of this Assignment.

8. FIRST ASSIGNOR and SECOND ASSIGNOR acknowledge and understand that the law firm of Calfee, Halter & Griswold LLP and its attorneys represent ASSIGNEE, and FIRST ASSIGNOR and SECOND ASSIGNOR acknowledge and understand that they are not the client of Calfee, Halter & Griswold LLP.


9. FIRST ASSIGNOR and SECOND ASSIGNOR acknowledge and understand that they have the opportunity to consult with independent legal counsel prior to executing this Assignment.
