This limited right granted to Robert Bosch GmbH with respect to any patent application or granted patent shall expire upon the first-occurring of (i) assignment to a third party of any of the above-mentioned rights of Assignee, or (ii) with respect to any particular patent, issue of such patent, and shall be subsequently part of the assignable rights of Assignee.
