For the purposes of this Assignment "Patent Rights" means the patents and applications for patents listed in the Schedule including any divisions, renewals, continuations, extensions or re-issues thereof along with any supplementary protection certificates relating thereto (where applicable).

- 2 This Assignment shall be governed by and interpreted in accordance with the laws of Scotland, and the parties hereby submit to the non-exclusive jurisdiction of the Scottish Courts in respect of any dispute arising hereunder.
