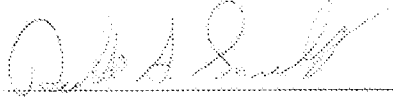
ASSIGNMENT OF PATENT APPLICATION BY INVENTOR

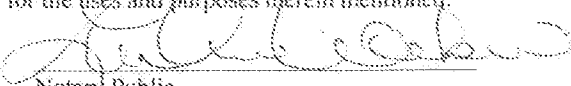
