I/WE HEREBY authorize and request competent authorities to grant and issue any and all patents on said invention to KING.COM LIMITED as the assignee of the entire interest therein; and I/we agree further to execute upon request of the Assignee or its attorneys such additional documents, if any, as are necessary and proper to secure patent protection on said invention throughout all countries of the world and to otherwise give full effect to and perfect the rights of the Assignee under this Assignment.
