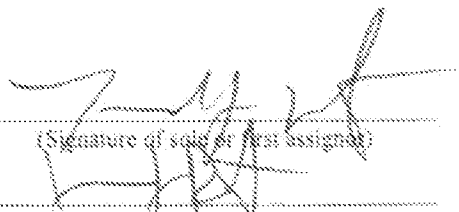
ASSIGNMENT DEED

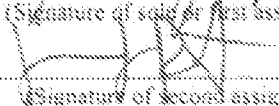
