SELL, ASSIGN AND TRANSFER to HzO, Inc., a Delaware corporation having a place of business at 12637 South 265 West, Suite 300, Draper, Utah 84020, United States of America ("ASSIGNEE"), the ASSIGNOR's entire rights, titles and interests for the United States and all other jurisdictions in and to (i) International Patent Application No. PCT/US2014/010510, filed on January 7, 2014 and titled "REMOVAL OF SELECTED PORTIONS OF PROTECTIVE COATINGS FROM SUBSTRATES" ("the '510 Application"); (ii) any and all improvements disclosed in the '510 Application ("the Improvements"); (iii) all divisional, continuing, substitute, renewal, reissue and all other applications for patent or the legal equivalent thereof which have been or may be filed in the United States and all other jurisdictions relating to any of the Improvements; (iv) all original, reissued, reexamined and reviewed patents or their legal equivalents which have been or shall be issued in the United States and all other jurisdictions on the Improvements; and specifically including (v) the right to file the Related Applications for patents or their legal equivalents under the provisions of any statute, convention or treaty and claim priority based on such applications (all of the foregoing, collectively the "Intellectual Property Rights");

AUTHORIZE the ASSIGNEE to apply for and receive, in its own name, any and all patents or their legal equivalents in any jurisdiction relating to the Improvements;

AUTHORIZE AND REQUEST the issuing authority to issue any and all patents or their legal equivalents granted in any jurisdiction any of the Improvements to and in the name of the ASSIGNEE;

WARRANT AND COVENANT that no assignment, grant, security interest, license or other agreement or encumbrance affecting the Intellectual Property Rights, or ASSIGNEE's rights to the Intellectual Property Rights has been or will be made or entered into by the ASSIGNOR, and that ASSIGNOR possesses the full right to convey the same as herein expressed and to provide ASSIGNEE with all rights, titles and interests in and to the Intellectual Property Rights;

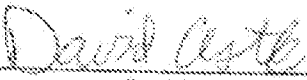
COVENANT, when requested and at the expense of the ASSIGNEE, to carry out in good faith the intent and purpose of this assignment, to execute all divisional, continuing, substitute, renewal, reissue, and all other applications for patents or their legal equivalents relating to any and all of the Improvements; to execute all rightful oaths, declarations, powers of attorney, assignments and other papers; to communicate to the ASSIGNEE all facts and provide to the ASSIGNEE all documents and things known and accessible to the ASSIGNOR relating to the Intellectual Property Rights, including, but not limited to, the Improvements and the histories thereof, and to testify as to the same in any interference, derivation or review proceeding, litigation or other proceeding relating to the Intellectual Property Rights, including, but not

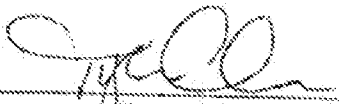

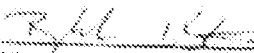
