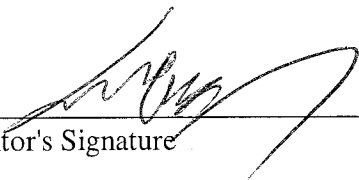
ASSIGNMENT OF PATENT APPLICATION
