**TERMINATION AND RELEASE OF SECURITY INTEREST IN
CERTAIN U.S. PATENTS AND PATENT APPLICATIONS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN CERTAIN U.S. PATENTS AND PATENT APPLICATIONS (the "*Patent Termination and Release*") dated as of September 21, 2015, from BANK OF AMERICA, N.A. (LaSalle National Bank), in its capacity as administrative agent (the "*Administrative Agent*") pursuant to a Security Agreement dated August 28, 1998 (the "*1998 Security Agreement*") between the Administrative Agent and Hunt Valve Company, Inc. (the "*Grantor*"), and pursuant to a Security Agreement dated July 25, 2003 (the "*2003 Security Agreement*") between BANK OF AMERICA, N.A. (successor by merger of LaSalle Bank National Association), in its capacity as collateral agent (the "*Collateral Agent*") and the Grantor. The Administrative Agent and the Collateral Agent are collectively referred to herein as the "*Agent*".

WITNESSETH:

WHEREAS, pursuant to the Security Agreements a security interest (the "*Security Interest*") was granted by the Grantor to the Agent in certain collateral, including the Specified Patent Collateral (as hereinafter defined), and

WHEREAS, the 1998 Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on September 3, 1998 at Reel 9414, Frame 385, including but not limited to those patents and patent applications set forth on Schedule I attached hereto; and

WHEREAS, the 2003 Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on July 30, 2003 at Reel 14327, Frame 201, including but not limited to those patent applications set forth on Schedule I attached hereto; and

WHEREAS, the Agent has agreed to release its Security Interest in the Specified Patent Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Definitions. The term "*Specified Patent Collateral*", as used herein, shall mean the Grantor's right, title and interest of every kind and nature as of the date hereof in the patents and patent applications described on Schedule I and Schedule II attached hereto.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Specified Patent Collateral described on Schedule I and Schedule II hereto without representation, warranty or recourse of any kind or nature. Except for

the foregoing release of the Security Interest in the Specified Patent Collateral, no other lien or security interest on the Grantor's assets (including other patents and patent applications) in favor of the Agent is released or terminated.
