2. I agree that, upon the request of Horsch, I will:


- (a) execute any and all divisional, continuation and renewal applications for the Invention or improvements;

- (e) perform any and all affirmative acts to obtain Letters Patent covering the Invention and vest all right in such Letters Patent in Horsch; and
- (f) perform such additional acts as Horsch may deem necessary or expedient in connection with any of the matters stated above.


