3. Authorize and request the Commissioner of Patents of the United States of America and the empowered officials of all other governments to record this assignment of Assignor's rights in said Letters Patents to Assignee, or otherwise as Assignee may direct;
4. Bind the Assignor and its heirs, legal representatives and assigns, to do, upon Assignee's request and at its expense, but without additional consideration to Assignor and its heirs, legal representatives and assigns, all acts reasonably serving to assure that said inventions and discoveries, said patent applications and said Letters Patents shall be held and enjoyed by Assignee as fully and entirely as the same could have been held and enjoyed by Assignor, its heirs, legal representatives and assigns if this assignment had not been made; and particularly to execute and deliver to Assignee all lawful affidavits in form and substance as may be requested by Assignee; to communicate to Assignee any and all facts known relating to said inventions and discoveries or the history thereof; and to furnish Assignee with any and all documents, photographs, models, samples and other physical exhibits in Assignor's control or in the control of Assignor's heirs, legal representatives or assigns and which may be useful for establishing the facts of conception,

disclosures, and reduction to practice of said inventions and discoveries.

5. Warrant that Assignor has not knowingly conveyed to others any right in said inventions, discoveries, applications or Letters Patents or any license to use the same or to make, use or sell anything embodying or utilizing any of said inventions or discoveries; and that Assignor has good right to assign the same to Assignee without encumbrance.
