RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTEREST IN PATENTS (this “Release”) is made as of July 29, 2015 by M&F TTP HOLDINGS LLC, as Collateral Agent (“Collateral Agent”), in favor of VTVX HOLDINGS I LLC (which prior to July 29, 2015 was known as vTv Therapeutics LLC, which prior to May 18, 2015, was known as TransTech Pharma, LLC) (the “Company”).

WHEREAS, the Company granted Collateral Agent, under the terms of that certain Patent Security Agreement, dated as of February 25, 2015, a continuing security interest (the “Security Interest”) in favor of Collateral Agent in and to certain of the Company’s intellectual property, including the patents and patent applications listed in **Schedule I** and all proceeds and claims based on past, present, or future infringement (collectively, the “Patent Collateral”);

WHEREAS, Collateral Agent has agreed to terminate and release its security interest in all the Patent Collateral as herein provided.



Collateral Agent consents and agrees to execute and deliver, at the request and cost of the Company, such further instruments, documents and release forms as the Company may reasonably request to more effectively, release, terminate and extinguish the Security Interest upon the Patent Collateral.
