## **ASSIGNMENT AND AGREEMENT**

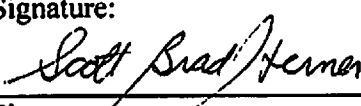

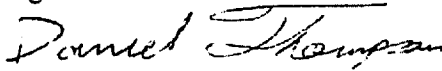
