- 2 **Grass Valley Australia Pty Ltd ABN 55 095 268 616**, having a principal place of business at Unit 8, 372 Eastern Valley Way, Chatswood, NSW 2067 Australia, and having a registered address at c/- McBurney & Partners, Level 10, 68 Pitt Street, Sydney NSW 2000 (**Assignee**)

Recitals

- A The Assignor is the owner of the patent applications (the Applications) and patents (the Patents) listed in Schedule 1.
- B The Assignor now wishes to assign to the Assignee the whole of its present and future interest in the Patents and Applications.

This deed witnesses as follows:

1 Assignment

For good and valuable consideration, the receipt of which the Assignor acknowledges, the Assignor assigns to the Assignee (and the Assignee accepts the assignment of):

- (a) the Assignor's right, title and interest throughout the world in and to the Patents and Applications, including, but not limited to (i) all patents granted from any of the Applications; (ii) the right to claim priority to the Patents and Applications in any divisional application, continuation application, continuation-in-part application, or other application for patent, and all patents granted thereon; and (iii) all reissues, renewals, reexaminations, and extensions of any of the foregoing and all patents issuing thereon; and
- (b) all rights, claims, demands, causes of action, rights of action past, present and future, if any, that it has arising out of or under the Patents and Applications, including but not limited to the right to sue for and recover damages (past, present and future) to which Assignor may be entitled,

with effect from the date of this deed.

2 Performance

- (a) The Assignor agrees, at the Assignee's request, to execute all documents and take any reasonable steps to enable the Assignee to be recorded as the owner of the Patents and Applications.
- (b) The Assignor irrevocably appoints the Assignee the Assignor's attorney-in-fact to execute all documents for and on behalf of the Assignor as the Assignor's attorney-in-fact under

power and to take any reasonable steps for and on behalf of the Assignor to enable the Assignee to be recorded as the owner of the Patents and Applications.

3 General

3.1 Governing Law and Jurisdiction

- (a) This deed is governed by the laws of New South Wales, Australia.
- (b) Each party irrevocably and unconditionally submits to the non-exclusive jurisdiction of the courts of New South Wales and the Commonwealth of Australia.

3.2 Invalidity

- (a) If a provision of this deed or a right or remedy of a party under this deed is invalid or unenforceable in a particular jurisdiction:
 - (i) it is read down or severed in that jurisdiction only to the extent of the invalidity or unenforceability; and
 - (ii) it does not affect the validity or enforceability of that provision in another jurisdiction or the remaining provisions in any jurisdiction.
- (b) This clause is not limited by any other provision of this deed in relation to severability, prohibition or enforceability.

3.3 Third party rights

Only the Assignor and the Assignee have or are intended to have a right or remedy under this deed or obtain a benefit under it.


