
Assignors hereby sell, assign, and transfer the entire right, title and interest to the Assignee as of the day of filing the applications identified above.


The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.




