## ASSIGNMENT

WHEREAS, Jacint HUMET, Jaime FERNANDEZ, Marc SERRA VALL and Eduardo AMELA were inventors of an invention subject to United States Patent Application Serial No. 14/646,270 filed May 28<sup>th</sup>, 2015 and entitled "OPERATION OF PRINTING SYSTEMS"
