"FIRST: The name of the corporation is Veeco ALD Inc. (the "Corporation").

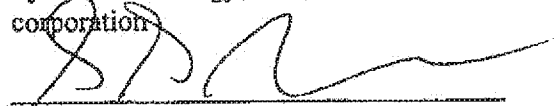
