

RELEASE

This Release Agreement ("Agreement") executed this 11 day of June 2015, by and between Luis Sifuentes and his sole proprietorship Auto Interiors of Mission Viejo (hereinafter referred to as "Releasor") and A Wood Products, LLC and its manager Adam Wood (hereinafter referred to as "Releasees"). Releasor and Releasees are collectively referred to as "Parties."

In consideration of the mutual promises exchanged between the Parties and referred to in this Agreement, and the patent Assignment to be executed concurrently herewith, the sufficiency of which are hereby acknowledged, Releasor and Releasees agree as follows:

Releasor acknowledges the Contract for Prototype Design Services ("Contract for Services") previously entered into by the parties and acknowledges that Parties have been acting and intend to continue to act in accordance with that Contract for Services and that Releasor has been paid for work invoiced pursuant to that Contract for Services paid in full pursuant thereto.

Releasor hereby releases and forever discharges the Releasees and their respective predecessors, successors, partners, assigns, employees, owners, officers, directors, agents, attorneys, subsidiaries, divisions, and affiliates, (jointly referred to as "Released Parties") from any and all claims, demands, causes of action, obligations, damages, attorneys' fees, costs and liabilities of any nature whatsoever, whether or not now known, suspected or asserted, which Releasor may have or claim to have against the Released Parties, including but not limited to any and all claims relating in any manner to Releasor's inventions, agreements, obligations, debts, claims, property, disputes, or any other interactions with the Releasees, but except for payment for Services pursuant to the Contract for Services, and hereby covenants not to assert such claims through a lawsuit, an administrative proceeding or otherwise.

Releasor waives all rights under Section 1542 of the Civil Code of California. That section reads as follows:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor."

Notwithstanding the provisions of Section 1542 or any similar law of any other state, and to provide a full and complete release of Released Parties, Releasor expressly acknowledges that this Agreement is intended to include, without limitation, all claims which Releasor does not know or suspect to exist in his favor at the time of execution of this document, and that this Release Agreement completely extinguishes all such claims.

Along with the patent Assignment, this Agreement is a full and complete expression of the intent of the parties with respect to the subject matter of this Agreement and the patent Assignment. No other agreement or representation, express or implied, has been made by either party with respect to the subject matter of this Agreement and the patent Assignment.

If any provision herein is held to be invalid or unenforceable for any reason, the remaining provisions will continue in full force without being impaired or invalidated in any way. The Parties agree to replace any invalid provision with a valid provision that most closely approximate the intent and economic effect of the invalid provision.

This Agreement may not be modified except by a written agreement signed by both

Releasor and Releasees.


This Agreement shall be interpreted to be valid to the full extent possible under the laws of the State of California.

Releasor warrants and represents that he has not assigned or in any way transferred any claim related to the subject matter of this Agreement and that he will not allow or assist in such transfer or assignment in the future.

This Agreement shall not constitute an admission by any of the Released Parties of any wrongful action or inaction whatsoever.

Releasor agrees that this Agreement is understood by Releasor and is voluntarily entered into by the Releasor.
