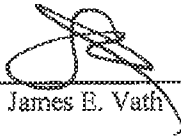

WHEREAS, the attached ASSIGNMENT erroneously lists Zafgen Corporation as the Assignee;

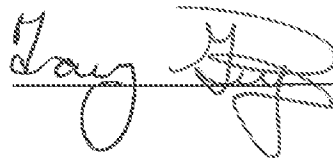

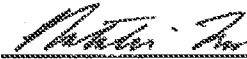

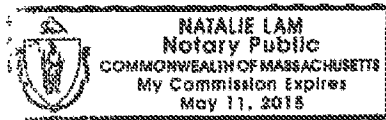
