WHEREAS, Kertzman Systems, Inc., formerly a Florida corporation, was the sole owner of the patent; and


WHEREAS, Kertzman Technologies, LLC. purchased the right, title and interest in the patent on August 2, 2010 and is now the sole owner of the patent; and
