WHEREAS I, **Jeffrey J. Thompson**, of 3625 Commercial Street, Vancouver, British Columbia, Canada, V5N 4G1, (hereinafter referred to as, the "**Assignor**"), have invented certain new and useful improvements described and claimed in an international application under the Patent Cooperation Treaty, filed on December 12, 2013 in the Canadian Receiving Office, with a convention priority claim based upon Canadian Patent Application Serial No. 2,798,599 filed December 14, 2012 (the "**Invention**"). The PCT Application being entitled:

SKIP-FIRE FUEL INJECTION SYSTEM AND METHOD

WHEREAS, I, Assignor, was an employee of **Westport Power Inc.**, whose full post office address is Suite 101 - 1750 West 75th Avenue, Vancouver, British Columbia, Canada V6P 6G2, (hereinafter referred to as, the "**Assignee**"), when I contributed to inventing the Invention, which I did in the course of my employment with Assignee, and by virtue of my employment or other contract with, or obligation to, Assignee, I have assigned all of my right, title and interest for, in and to the Invention to Assignee;

AND WHEREAS, Assignee was desirous of acquiring, and as of the date of invention of the Invention, did acquire all right, title and interest for, in and to: (i) the Invention worldwide; (ii) any and all applications for Letters Patent for the Invention in all countries and jurisdictions and under all conventions and treaties, including the right to claim for any and all applications any priority rights to which such applications are entitled under conventions, treaties or otherwise, and all divisions, extensions, continuations, continuations-in-parts, provisionals, non-provisionals, substitutions, and renewals thereof; (iii) all Letters Patent which may be granted therefor in any and all countries and jurisdictions, and any renewals, re-examinations, reissues, and/or extensions of the Letters Patent; and (iv) the exclusive right to bring or participate in any proceeding for past infringement or any other actionable right under all of the foregoing and to receive all remedies that arise therefrom, to the end of the term for which the Letters Patent may be granted (collectively, the "**Patent Rights**").

NOW THEREFORE, AS WITNESSED in consideration of the sum of ONE CANADIAN DOLLAR (\$1.00) and for other good and valuable consideration, the receipt and sufficiency of which I, Assignor, acknowledge and accept, I, Assignor, do hereby agree to the following terms:

I. ASSIGNMENT

For said consideration, I, Assignor, do hereby confirm having sold, assigned, transferred and set over absolutely to Assignee, as of the date of invention of the Invention, all right, title and interest for, in and to the Patent Rights, and by way of further assurances, do hereby sell, assign,

transfer, and set over absolutely to Assignee all right, title and interest for, in and to the Patent Rights absolutely free and clear of all liens, encumbrances and interests of third parties.

And for said consideration, it was covenanted and agreed that, at the request of Assignee, its successors, assigns, nominees and legal representatives, I, Assignor, would execute any further papers and do such other acts and things as may be necessary and proper to procure Letters Patent for said Invention in all countries as Assignee, its successors, assigns, nominees and legal representatives may elect, and vest the full title thereto in Assignee, its successors and assigns.

I, Assignor, hereby covenant that I have not executed and will not execute any agreement, assignment, or license in conflict herewith, and I further covenant and agree, each time a request is made, and without delay or further consideration, to do such acts, and execute such further documents, agreements and assurances, at Assignee's expense, that Assignee, its successors, assigns, nominees and legal representatives may, in their absolute discretion, request, in order to protect, perfect, maintain and enforce the Patent Rights herein.

II. ISSUANCE OF FUTURE PATENTS IN THE NAME OF WESTPORT POWER INC.


I, Assignor, hereby authorize and request the Patent Office Officials in Canada and any official of any and all countries and jurisdictions foreign to Canada whose duty it is to issue patents, to issue any and all of said Letters Patent for the Invention, including reissues or extensions thereof, when granted, to Assignee, as the assignee of my entire right, title and interest in and to the same, for the sole use and behoof of Assignee, its successors and assigns, to the full end of the term for which said Letters Patent may be granted, as fully and entirely as the same would have been held by me had this Confirming Assignment and sale not been made.
