RELEASE OF PARITY LIEN SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

This RELEASE OF PARITY LIEN SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of September 30, 2015, is made by Wilmington Trust Company, as collateral trustee (the "Collateral Trustee"). Capitalized terms not otherwise defined shall have the meanings given to such terms in the Indenture.

WHEREAS, AMERICAN ACHIEVEMENT CORPORATION (the "<u>Company</u>") entered into that certain Indenture, dated as of November 1, 2010 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "<u>Indenture</u>"), among the Collateral Trustee, the Company, the Guarantors party thereto and Wells Fargo Bank, National Association, as trustee, under which the Company issued 10.875% Senior Secured Notes upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Indenture, each Grantor (as defined in the Parity Lien Security Agreement), other than the Company, agreed, pursuant to a Parity Lien Security Agreement, dated as of November 1, 2010, in favor of the Collateral Trustee (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Parity Lien Security Agreement"), to guarantee the Secured Obligations (as defined in the Parity Lien Security Agreement) of the Company;

WHEREAS, all of the Grantors (as defined in the Parity Lien Patent Security Agreement) are party to the Parity Lien Security Agreement and executed and delivered a Parity Lien Patent Security Agreement, dated as of November 1, 2010, in favor of the Collateral Trustee (the "Parity Lien Patent Security Agreement") that provided for security in the following Collateral: all of its Patents (as defined in the Parity Lien Patent Security Agreement) providing for the grant by or to such Grantor of any right under any such Patent, including, without limitation, those referred to on Annex I hereto; all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the foregoing Patents, and all income, royalties, proceeds and Liabilities (as defined in the Parity Lien Patent Security Agreement) at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof (collectively, the "Patent Collateral"); and

WHEREAS, the security interests in the Patent Collateral listed on <u>Annex I</u> were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth in the records thereof.

NOW THEREFORE, the Collateral Trustee hereby RELEASES, without representation, recourse or warranty whatsoever, all of its security interest in the Patent Collateral, whether granted pursuant to the Parity Lien Security Agreement, the Parity Lien Patent Security Agreement or any other agreement or document delivered in connection with the Indenture, and the Collateral Trustee hereby reassigns any and all such right, title and interest (if

any) that the Collateral Trustee may have in the Patent Collateral to the Grantors including the right to sue and recover for past infringements and misappropriations.

The Collateral Trustee agrees, at the Grantors' expense, to cooperate with the Grantors and to provide the Grantors with the information and additional authorization reasonably required or desirable to effect the release of the Collateral Trustee's security interest in the released collateral described herein.
