States and any Letters Patent that may issue thereon, or therefore, in the United States and foreign countries and all reissues, extensions, renewals, divisions and continuations thereof, to the full end of the term or terms for which said Letters Patent may be issued, to be held and enjoyed by the said Assignee, its successors and assigns the same as it would have been held and enjoyed by **TING-CHI CHEN**, if this assignment and sale had not been made.

AND, **TING-CHI CHEN**, hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all such Letters Patents to the said Assignee, in accordance with this instrument of assignment.


