ASSIGNMENT

We hereby authorize and request the Patent Office to assign the above-identified Patent to Sheex, LLC as the assignee of our entire right, title, and interest in and to the same.

Further, we will communicate to Sheex, LLC any facts known to us respecting said invention, and testify in any legal proceedings, sign all lawful papers, make all rightful oaths, and generally do everything possible to aid said Sheex, LLC, its successors and assigns, to obtain and enforce proper protection for said invention and Patent Rights and Letters Patent in the United States, and in any and all foreign countries.


