patents for said invention and for additions and modifications thereto in any and all countries, and to vest title thereto in said Assignee, its successors, assigns, and legal representatives or nominees.

The Assignor authorizes and empowers said Assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any application for patent or other form of protection for said invention or for additions and modifications thereto, filed by it or them, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from the Assignor.

The Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue said Letters Patent to the Assignee, for its sole use and benefit, and for the use and benefit of its successors and assigns, to the full end of the term for which Letters Patent may be granted, as fully and entirely as the same would have been held by the Assignor had this assignment and sale not been made.
