PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT is made this 31st day of December, 2014 (“Assignment”) by and between Weatherford Canada Partnership, a partnership organized under the laws of Canada with a business address at 333 5th Ave SW #1200, Calgary, Canada T2P3B6 (“Assignor”), and Lubrizol Oilfield Solutions, Inc., a Delaware corporation with a business address at 29400 Lakeland Blvd., Wickliffe, Ohio 44092 (“Assignee”).

WHEREAS, Weatherford International Ltd., a Bermuda exempted company (“Weatherford”), The Lubrizol Corporation, an Ohio corporation (“Lubrizol”) and LZ Holding Corporation, a Delaware corporation (“LZ”, and together with Lubrizol, collectively “Acquiror”) have entered into an Acquisition Agreement (the “Acquisition Agreement”) dated as of November 30, 2014.

WHEREAS, in accordance with the Acquisition Agreement, Assignor has agreed to execute this Assignment to transfer to Assignee of all of Assignor’s right, title and interest in and to the patents and patent applications as set forth on the attached Schedule I (“Patents”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged the parties, Assignor and Assignee agree as follows.

1. Assignment. Assignor hereby assigns, sells, transfers and conveys to Assignee, its successors and/or assigns its entire right, title and undivided interest in and to the Patents, in the United States of America and its territorial possession and in all foreign countries, and to all patents, utility models, design patents, inventor’s certificates,

continuations, divisions, registrations, renewals and/or any reissue or reexamination resulting therefrom, including the right to claim priority to the Patents.

Assignor further hereby assigns, sells, transfers, and conveys to Assignee its right to enforce the Patents against any third party for any and all claims for damages by reason of past infringement of the Patents and the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors and/or assigns.

2. Definitions. Unless otherwise defined herein, terms capitalized and used herein will be defined as they are defined in the Acquisition Agreement.

3. Governing Law. This Agreement shall be governed in all respects, including as to validity, interpretation and effect, by the internal laws of the State of Texas without regard to choice of law principles.


4. Counterparts. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original and all of which shall together constitute one and the same instrument.

5. Amendments. This Assignment shall not be amended, modified, or supplemented except by a written instrument signed by an authorized representative of each of the parties hereto.



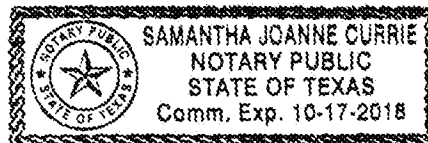
