**ASSIGNMENT BY INVENTOR**



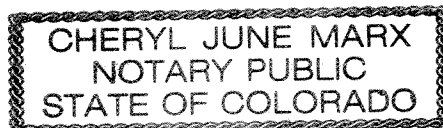
