ASSIGNMENT

KG the full and exclusive rights to the invention aforesaid in the United States of America; and I do hereby authorize and request the Director of the United States Patent and Trademark Office to issue all future patents granted on said application or on the subject matter disclosed therein to the above-named assignee, its legal representatives, successors, and assigns.
