DESIGN ASSIGNMENT DEED

THIS DEED is made effective as of 10 July 2015.

Parties

1. Robert Silver of 2 Brisbane Street, Fairlight, New South Wales 2094, Australia (the *Assignor*)
2. Kids Bike Buckets Pty Ltd (ABN 58607011585) of 2 Brisbane Street, Fairlight, New South Wales 2094, Australia (the *Assignee*)

Recitals

- A. The Assignor is the sole proprietor of a registered design relating to a bicycle basket (*Product Design*), being Australian Registered Design No 362130, filed on 29 April 2015 (*Design Registration*).
- B. The Assignor has agreed to assign to the Assignee all the Assignor's right, title and interest in and to the Product Design and the Design Registration and any copyright subsisting in drawings of the Product Design and the Assignee has agreed to take an assignment of the Product Design and Design Registration.

It is agreed as follows:

1.1 Assignment

In consideration of the sum of A\$1.00 and other good and valuable consideration, receipt of which is hereby acknowledged by the Assignor, the Assignor assigns to the Assignee:

- a) all of the Assignor's right, title and interest in and to the Product Design and Design Application;
- b) the Assignor's copyright subsisting in any drawings of the Product Design and in the Design Application; and
- c) the right to sue for any infringement relating to the Product Design occurring prior to the date of this Deed and the right to recover damages for that infringement.

1.2 Warranties

The Assignor warrants that:

- a) he is the true proprietor of the Product Design and Design Registration; and
- b) he has not done, failed to do, permitted or assisted and will not do, fail to do, permit or assist anything that may invalidate the Design Registration or that may put the Assignee's title to the Product Design or Design Registration in dispute.

Design Assignment Deed

- 1.3 Further Assurance** The Assignor agrees to do all acts, including executing all documents, necessary or desirable to give full effect to this Deed, including documents relating to other design applications, in Australia or elsewhere, in relation to the Product Design and the Design Registration.
- 1.4 Amendment** No amendment or variation of this Deed is valid or binding on a party unless made in writing and executed by all parties.
- 1.5 Counterparts** This Deed may be made in any number of counterparts, all of which together will be taken to constitute one instrument.
- 1.6 Governing Law** This Deed is governed by and construed in accordance with New South Wales law and the parties agree to submit to the non-exclusive jurisdiction of the courts of New South Wales.
