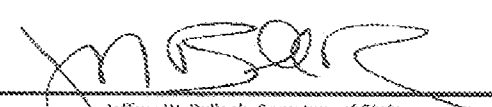

AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF
EXPLORAMED NC6, INC.**

1. He is the President and Chief Executive Officer of ExploraMed NC6, Inc.
2. Article ONE of the Certificate of Incorporation is amended to read in its entirety as follows:

"The name of the Corporation is Nuelle, Inc. (the "Corporation")."
3. The first paragraph of Article FOUR of the Certificate of Incorporation is amended to read in its entirety as follows:

"The Corporation is authorized to issue two classes of stock to be designated Common Stock and Preferred Stock. The total number of shares of Common Stock which the Corporation has authority to issue is [REDACTED], with par value of \$[REDACTED] per share.
