CONFIRMATORY PATENT ASSIGNMENT

This Confirmatory Patent Assignment ("Assignment") dated effective October 31, 2010, by and between Achiever Corporation, an administratively dissolved Nevada corporation ("Assignor"), and David Blachley, an individual ("Assignee").

WHEREAS, Achiever Corporation was owned and operated by David Blachley at all times since its formation and until its administrative dissolution by the Secretary of State of Nevada on October 31, 2010;

WHEREAS, for the purpose of attracting investors to the business venture of Achiever Corporation, David Blachley executed an assignment of his rights, title and interest in and to United States Patent No. 6,622,433, including all divisions, renewals and continuations thereof, to Achiever Corporation, and its successors, legal representatives, and assigns, effectively dated October 1, 2008 and subsequently recorded on December 30, 2009. Said assignment is referred to herein as "Achiever Assignment;"

WHEREAS, prior to execution and recording of the Achiever Assignment, on June 6, 2006, a continuation of United States Patent No. 6,622,433 was issued, bearing United States Patent No. 7,055,231;

WHEREAS, subsequent to execution and recording of the Achiever Assignment, on May 26, 2009, a continuation of United States Patent No. 7,055,231, which is a continuation of United States Patent No. 6,622,433, was issued, bearing United States Patent No. 7,536,766;

WHEREAS, subsequent to execution and recording of the Achiever Assignment, on August 2, 2011, a continuation of United States Patent No. 7,055,231, which is a continuation of United States Patent No. 6,622,433, was issued bearing United States Patent No. 7,987,565;

WHEREAS, subsequent to execution and recording of the Achiever Assignment, on January 10, 2012, a continuation of U.S. Patent Application Ser. No. 10/642/981, abandoned, which was a divisional of U.S. Patent No. 6,622,433, was issued, bearing United States Patent No. 8,091,281;

WHEREAS, by virtue of a Nunc Pro Tunc Assignment, effectively dated October 31, 2010, David Blachley acquired from Achiever Corporation the entire right, title and interest in and to United States Patent No. 6,622,433. Said assignment is referred to herein as "Blachley Assignment;"

WHEREAS, in order to clarify the rights, title, and interest acquired by David Blachley in the previously recorded Blachley Assignment, this Assignment confirms the patents which were to be transferred under the Blachley Assignment by referencing the continuations and division of United States Patent No. 6,622,433, including United States Patent No. 7,055,231; United States Patent No. 7,536,766; United States Patent No. 7,987,565; and United States Patent No. 8,091,281 (collectively referred to as "Continuations");

NOW THEREFORE, David Blachley, in his capacity as Chief Executive Officer and owner


