## STATE OF DELAWARE CERTIFICATE OF MERGER

Mitel Mobility Inc., a Delaware corporation (the “**Surviving Corporation**”), in order to merge each of Mavenir Holdings, Inc., a Delaware corporation (“**MHI**”), Mavenir International Holdings, Inc., a Delaware corporation (“**MIHI**”), Mavenir Systems IP Holdings, LLC, a Delaware limited liability company (“**MSIP**”), Utah France Corporation, a Delaware corporation (“**UFC**”), Utah Holding Corporation, a Delaware corporation (“**UHC**”), Utah Intermediate Holding Corporation, a Delaware corporation (“**UIHC**” and, together with MHI, MIHI, MSIP, UFC and UHC, the “**Merging Companies**” and the Merging Companies, together with the Surviving Corporation, the “**Constituent Entities**”), with and into the Surviving Corporation, hereby certifies as follows pursuant to Sections 251 and 264 of the Delaware General Corporation Law (the “**DGCL**”):

**FIRST:** That the name and state of domicile of each of the Constituent Entities of the merger being effected hereby (the “**Merger**”) are as follows:

**SECOND:** That an Agreement and Plan of Merger, dated as of September 30, 2015, among Mitel US Holdings, Inc., a Delaware corporation, and each of the Constituent Entities (the “**Merger Agreement**”), has been approved, adopted, certified, executed and acknowledged by each of the Constituent Entities in accordance with the DGCL.

**THIRD:** That the surviving corporation of the Merger is Mitel Mobility Inc., a Delaware corporation.

**FOURTH:** That the Certificate of Incorporation of the Surviving Corporation in effect immediately prior to the effective time of the Merger shall continue to be the Certificate of Incorporation of the Surviving Corporation upon the effectiveness of the Merger.

**FIFTH:** That this Certificate of Merger shall be effective upon filing.

**SIXTH:** That the Merger Agreement is on file at 1700 International Parkway, Suite 200, Richardson, Texas, 75081, the place of business of the Surviving Corporation.
