Company hereby further covenants and agrees that it will communicate to ASSIGNEE any and all facts known to it respecting said Patents, and testify in any legal proceeding, sign all lawful papers, execute and deliver all papers and take any actions that may be necessary or desirable to perfect the title to any aforementioned patents and inventions, and execute all divisional, continuation, reexamination, reissue and substitute applications.

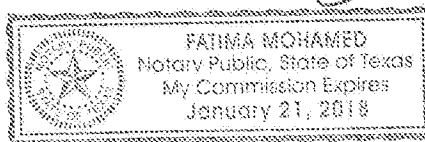
