**TERMINATION AND RELEASE OF SECURITY INTEREST
(Patents)**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST, dated as of October 13, 2015, is made by Guggenheim Corporate Funding, LLC, in its capacity as collateral agent (in such capacity, the “Collateral Agent”) for the Secured Parties (as defined in the Credit Agreement defined below). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement, as applicable, referred to below.

WHEREAS, Merge Healthcare Incorporated, a Delaware corporation (the “Company”), the Subsidiaries of the Company party thereto as Subsidiary Guarantors (the “Subsidiary Guarantors”, and together with the Company, collectively, the “Grantors”), the financial institutions from time to time party thereto as Lenders (the “Lenders”) and Guggenheim Corporate Funding, LLC, as Administrative Agent and as Collateral Agent, entered into that certain Credit Agreement, dated as of April 29, 2014 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”);

WHEREAS, in connection with the Credit Agreement, the Grantors and the Collateral Agent entered into that certain Security Agreement, dated as of April 29, 2014 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), pursuant to which each of the Grantors granted to the Collateral Agent a security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in, to and under any Patents now owned or at any time hereafter acquired by such Grantor, including, without limitation, those identified on Schedule A hereto (the “Patents”);

WHEREAS, in order to further evidence the Security Interest of the Collateral Agent in all of the Patents of the Grantors, the Grantors party thereto and the Collateral Agent entered into that certain Patent Security Agreement, dated as of April 29, 2014, made by the Grantors party thereto in favor of the Collateral Agent, which Patent Security Agreement was recorded at the United States Patent and Trademark Office on April 29, 2014 at Reel 032784 and Frame 0644; and

WHEREAS, in connection with the termination of the Commitments and repayment of all outstanding Loans and other Obligations in full under the Credit Agreement, the Collateral Agent has agreed to terminate and release its Security Interest in all of the Patents of the Grantors, including, without limitation, those identified on Schedule A hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, releases, cancels, relinquishes and discharges its Security Interest, and any right, title or interest of the Collateral Agent in all of the Patents of each Grantor, including the following Patents:

1. all Patents of each Grantor, including the patents and patent applications listed on Schedule A attached hereto;
2. all reissues, continuations or extensions of the foregoing; and


3. all Proceeds of any and all of the foregoing, including, without limitation, any claim by any Grantor against third parties for past, present or future infringement of any Patent set forth on Schedule A hereto.

The Collateral Agent agrees to execute and deliver to any Grantor all documents that such Grantor shall reasonably request to evidence such termination and release. All of the foregoing shall be at the sole expense of such Grantor.
