ASSIGNMENT

WHEREAS, We, Nico Flemming, a citizen of Germany residing at 193 Log Circle, Waterloo, South Carolina 29384; David Edward Drosback, a citizen of the United States residing at 61 Brockmore Drive, Greenville, South Carolina 29605; Abhishek Baradwaj Raydurga Palegar, a citizen of India residing at 2207 Arbor Keats Drive, Simpsonville South Carolina 29680; and Thomas Geiss, a citizen of the United States residing at 19 Suwannee Ct., Simpsonville, South Carolina 29680, (hereinafter referenced as ASSIGNORS), have invented a certain new and useful invention entitled Automatic Transmission and a Dog Clutch for an Automatic Transmission, for which an application for Letters Patent of the United States has been filed in the United States Patent and Trademark Office on June 3, 2015, as Application Serial No. 14/729,334;

And we hereby agree, at the expense of ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue, and substitute applications, make lawful oaths and declarations, and generally do everything possible to vest title in ASSIGNEE and to aid ASSIGNEE to obtain and enforce proper protection for said invention in all countries.

And we hereby agree to transfer a like interest, upon the request of said ASSIGNEE, its successors, assigns and legal representatives, and without further remuneration, in and to any

improvements, and applications for patent based thereon, growing out of or related to the said invention; and to execute any papers by the said ASSIGNEE, its successors, assigns and legal representatives, deemed essential to ASSIGNEE's full protection and title in and to the invention hereby transferred.

Agreeing furthermore, upon request of said ASSIGNEE, and without further remuneration, to execute any and all papers desired by said ASSIGNEE for the filing and granting of applications and the perfecting of such right, title, and interest thereto in said ASSIGNEE.
