described and claimed in an application for Design Patent of the United States of America thereon, said application having Application Serial No. 29/535,815, filed August 11, 2015; and

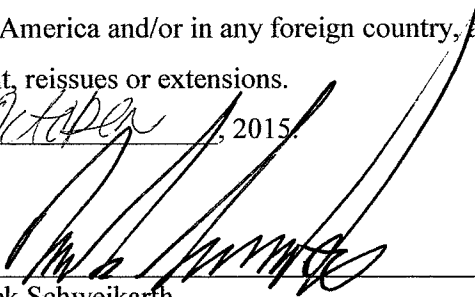

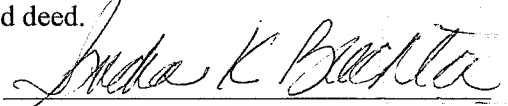
