We hereby covenant and agree that we will communicate to the Assignee or nominees all facts known to us pertaining to said inventions and improvements, and we agree for ourselves and our respective heirs, legal representatives, and assigns, without further compensation to perform such lawful acts and to sign such further applications, assignments, reissues, Preliminary Statements, and other lawful documents, testify in all legal proceedings, make all rightful oaths and declarations, and in general perform or cause to be performed all lawful acts necessary or proper to aid the Assignee or nominees in obtaining, maintaining, and enforcing all lawful patent protection for the inventions and improvements in the United States and in foreign countries; and

We hereby covenant that we have the full right to convey the entire right, title, and interest herein assigned and that we have not executed and will not execute any agreement in conflict herewith.

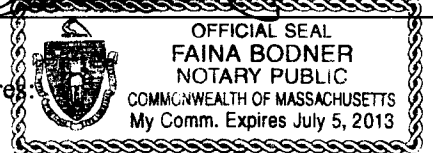
