(i) in and to (a) **United States Patent Application No. 14/576,818**, filed **December 19, 2014**, entitled "**System and Method for Identifying Faces in Unconstrained Media**" (the "Patent Application"), (b) patents or patent applications (1) to which the Patent Application claims priority, (2) for which the Patent Application forms a basis for priority, (3) that were Assignor co-owned applications that incorporate by reference the Patent Application (excluding for this purpose mere prior art references that are not incorporated by reference) and/or (4) which are subject to a terminal disclaimer with the Patent Application; (c) reissues, reexaminations, extensions, continuations, continuations in part, continuing prosecution applications, requests for continuing examinations, divisions, and registrations of any item in the foregoing categories (a) and (b); (d) foreign patents, patent applications and counterparts claiming priority to any item in any of the foregoing categories (a) through (c), including, without limitation, certificates of invention and utility models; and (e) any other patents or similar rights under any country's laws owned by the Assignor as of the Closing, together with the items listed in subsections (b) through (e), collectively, the ("Assigned Patent Application"), the same to be held and enjoyed by Assignee for its own use, and for the use by its successors, assigns, or other legal representatives to the end of the term or terms for which the Assigned Patent Application may be granted as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made;

(ii) in and to causes of action and enforcement rights for the Assigned Patent Application, including all rights to pursue damages, injunctive relief and other remedies for past and future infringement of the Assigned Patent Application, except for those attributable to the Permitted Invoices; and

(iii) to apply in any and all countries for patents, certificates of invention or other governmental grants for the Assigned Patent Application. Assignor also hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents or certificates of

invention which may be granted upon the Assigned Patent Application in the name of Assignee, as the assignee to the entire interest therein.


