**SECURITY INTEREST**  
**IN UNITED STATES PATENT**

November 5, 2015

**FOR GOOD AND VALUABLE CONSIDERATION**, the receipt and sufficiency of which are hereby acknowledged, OIA Global Logistics - SCM, Inc., an Oregon corporation (the "Grantor") with principal offices at 2100 SW River Parkway, Portland, Oregon 97201, hereby grants to JPMorgan Chase Bank, N.A., as administrative agent, with principal offices at 10 South Dearborn, Chicago, Illinois 60603 (the "Administrative Agent"), a security interest in all of the following property, whether now owned or hereafter acquired or existing: (i) all of the Grantor's right, title and interest in and to the United States patent set forth on Schedule A (the "Patent"), together with (ii) all causes of action arising prior to or after the date hereof for infringement of the Patent and (iii) all proceeds of the foregoing.

**THIS SECURITY INTEREST** (this "Agreement") is made to secure the satisfactory performance and payment of all Secured Obligations of the Grantor under the Loan Documents, as such terms are defined in, or by reference in, the Pledge and Security Agreement among the Grantor, certain other parties party thereto from time to time and the Administrative Agent, dated as of November 5, 2015 (the "Security Agreement"). Capitalized terms used but not defined herein have the respective meanings assigned to such terms in the Security Agreement, including by reference to other documents. Upon request of the Grantor when all Secured Obligations have been paid in full and all Commitments have been terminated, the Administrative Agent shall execute, acknowledge and deliver to the Grantor an instrument in writing releasing the security interest in the Patent acquired under this Agreement.

This security interest has been made in conjunction with the security interest granted to the Administrative Agent under the Security Agreement. The rights and remedies of the Administrative Agent with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in, the Security Agreement, the terms and provisions of which are incorporated herein by reference. If any provision of this Agreement conflicts with the Security Agreement, the provisions of the Security Agreement shall govern.


