3. Warrant that Assignor has not knowingly conveyed to others any right in said invention, discoveries, applications or patents or any license to use the same or to make, use or sell anything embodying or utilizing any of said inventions or discoveries; and that Assignor has good right to assign the same to Assignee without encumbrance;

4.
