Assignor does hereby agree for itself, its successors, assigns or other legal representatives to execute any and all papers, including applications for Letters Patents of any and all kinds and in any and all countries and to perform any and all acts which Assignee, its successors, assigns or other legal representatives may deem necessary to secure thereto the rights herein assigned, sold and set over. Assignor does further hereby assign, sell and set over to Assignee all causes of action, rights, and remedies arising under any such Letters Patents or patent applications prior to or after the effective date of this assignment, including the right to sue for past infringements.
