SATISFACTION OF NOTE AND ASSIGNMENT OF PATENT RIGHTS

This Agreement is by and between EnerSea Transport LLC, a Texas limited liability company, ("EnerSea"), Charles N. White ("White") and Alan C. McClure Associates, Inc. ("McClure").

EnerSea further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in White and McClure. EnerSea will testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation in part, reissue and substitute applications, make lawful oaths and declarations, and generally do everything possible to vest title in White and McClure and to aid White and McClure to obtain and enforce proper protection for the Collateral in all countries.


White and McClure assume all responsibility with respect to prosecuting patent applications and maintaining patents in the Collateral.




