AND WHEREAS Feel Life INC., of China, the assignee, whose mailing address is 5923 Cloverly ave : temple city, California, USA, 91780,


is desirous of acquiring the entire right, title and interest in and to said DESIGN, and in and to Any Letters Patent that may be obtained therefor;
