## Agreement for Assignment of Patent and Patent Rights

This Agreement for Assignment of Patent and Patent Rights is executed this 13th day of April, 2013, between Mark Mathis ("Patentee") and Confluence Energy, LLC ("CE").

WHEREAS, Patentee is employed as the Chief Executive Officer of CE pursuant to an Employment Agreement dated January 1, 2012 in which Patentee agreed to transfer all rights, claims, and interests that he has, had, or may have, to all Patents and Patent Applications related to the business of CE; and

WHEREAS, Patentee, as the named Inventor, applied for and was issued United States Patent No. 8,389,270, which relates to the business conducted by CE; and

WHEREAS, Patentee, as required by his Employment Agreement, desires to sell, assign, and transfer to CE all rights, claims, and interests that he has and may have to Patents and applications for Patents now pending.

NOW for good and valuable consideration, the receipt of which is mutually acknowledged, the parties agree as follows:

1. On March 5, 2013, United States Patent No. 8,389,270 for "Compositions and Methods of Waste Bioremediation" was issued to Patentee. Additionally, Patentee has filed four Patent Applications relating to the business conducted by CE which are pending in the United States Patent Office. The Patent and the Patent applications are described on Exhibit A.

2. Patentee sells, assigns, and transfers to CE all rights, claims, title, and interest held by Patentee in the Patent and in the Patent applications identified in Exhibit A to the full end of the term for which the Patents are, or may be granted.


3. Patentee will perform all actions reasonably requested by CE to establish and confirm CE's exclusive ownership of Patent No. 8,389,270 and for all Patents issued, which relate to Patent Application Serial numbers 2,791,22, 13/779,460, and 61/738,942.

4. CE will allow Patentee to convert 1,790,000 of his Common Ownership Units in CE, into 1,790,000 Class A Ownership Units in CE.

5. This Agreement shall be governed by the laws of the State of Colorado.


